

Persecution by CSIS - Harper Government Covers-up

This letter was sent to then opposition Members of Parliament in late June. Self-explanatory it raises Human Rights issues that go deeply into the quality of our democracy in Canada today:

Dear (MP's name)

I am bringing to your attention a record of extreme abuse by **CSIS** that is being covered-up by the Harper Government. Based in Calgary, I am a Chartered Accountant with a former background as Chief Financial Officer of large international companies.

Several years ago, my wife and I were put under **surveillance by CSIS** and began to get **stalked, harassed, intimidated, and threatened** on an ongoing basis. All our communications - telephone, email, etc. - are tapped. I have never done anything illegal, yet we have been subjected to what amounts to extreme punishment by CSIS without trial.

Indeed it is just because I have never done anything wrong (i.e. CSIS made a mistake in targeting us in the first place) that the persecution has been so severe - CSIS are scared this shocking story will get out and, with the connivance of the Harper Government, they are trying to terrorize my wife and I into silence. I should just mention that their abuse of my family has nothing whatsoever to do with national security.

Zersetzen was developed by the former East German secret police (the STASI) to persecute dissidents. Today some of our own Spy Agencies are using Zersetzen techniques to bully innocent citizens and whistleblowers for private power elites – and in situations that have nothing whatsoever to do with national security.

Zersetzen combines character assassination and slander with intimidation, harassment, surveillance, cyberbullying and threats. Sometimes called “no touch” torture or Cointelpro, these vicious “Zersetzen” tactics are being used illegally by Spy Agencies to poison every aspect of their victims’ lives.

Call it what you want - **Zersetzen**, “**D and D**”, **Cointelpro**, **Zersetzung** - these Stasi-style persecution programs are all the same thing and are being used by CSIS today in violation of the laws of Canada. CSIS must have seen the contentious debate on C-51 as a joke since CSIS are already way past that in what they have been doing for years.

19 minutes into this video there is a series of training slides that proves that Spy Agencies such as CSIS are training their staff in secret police tactics (i.e. Zersetzen).

These secret police tactics are designed in their own words to “**destroy**”, “**disrupt**”, “**diffuse**” and “**discredit**” their victims.

According to the training slides the stated objective of this revolting secret police program is to achieve “**Physiological Stress**”, “**Cognitive Stress**” and “**Affective Stress**” in their target victims.

Is this a legitimate role for an intelligence organization like CSIS? It is what my wife and I have been subjected to for years. Kick the tire, look at the slides, and see for yourself.

What level of proof is there that these abuses have happened?

At the end of this email is a URL reference to my Web Site. On this site is a descriptive list (called “Russell Zersetzen”) of the threatening incidents that have happened to us over the years (*120 of these incidents are **fully corroborated** and can be verified by independent 3rd parties*). I will happily meet in Calgary to provide sources of corroboration that can easily be checked out for verification purposes.

What is the proof that the Harper Government is covering-up to pervert justice?

Well, when a Spy agency like **CSIS** is involved in a matter like this, all normal avenues of grievance (policing, etc.) seize up. As for the SIRC - Not one single witness of mine was checked by these people. Some call this Wilful Blindness. **They didn't want to know the truth**. Yet we were being criminally threatened and harassed by CSIS just for complaining to the SIRC (and some of these threats were independently witnessed and are described in the article below).

I published this article on our experiences with CSIS/SIRC in the UK based Lobster Magazine. To do this in the toughest libel jurisdiction in the world I had to prove that the facts are backed by strong corroborative evidence. The article's headline says it all.

“Canada’s Spy Agency gone rogue: Prime Minister Harper couldn’t care less”

The last few paragraphs of this article deal with the cover-up. It is impossible to read the article without concluding that there is sufficient evidence to prove that the **PMO at senior levels is involved in a cover-up** conspiracy to pervert justice.

*I and others also brought our complaint of cover-up to the **PMO in writing** on several occasions. I **visited Mr. Harper’s constituency office** where his Manager agreed to get a letter from me to him personally. We have friends who also know Mr. Harper who when out at lunch with my wife noticed - and commented on the fact - that my wife was clearly being followed and watched (i.e. stalked).*

The measure of a democracy is surely not that the rule of law is enforced when power elites wish it to be enforced, but that it is still enforced impartially when they don’t.

I am taking the liberty of contacting you since this matter is political.
